Instead, it relies on a broad array of policies aimed at ensuring energy security, promoting sustainability and achieving universal access all while aligning with cross-cutting strategies from other ministries.

What are Brazil's electrical standards?

Brazil's electrical standards are shaped by a combination of international best practices and domestic policies. The country relies heavily on the Brazilian Association of Technical Standards (ABNT), which establishes regulations for everything from wiring to grounding.

Who regulates electricity in Brazil?

In Brazil, the electricity regulatory agency (Agência Nacional de Energia Elétrica - ANEEL) was created in 1996, following the electric sector privatization in 1995 (Silvestre et al., 2010). ANEEL regulates the electricity distribution tariffs through detailed tariff review procedures.

Through its work, the IEA advocates policies that will enhance the reliability, affordability and sustainability of energy in its 32 Member countries, 13 Association countries and beyond.

Amending several aspects of existing legislation, the provisional measure will remain in effect for up to 120 days, during which it will be reviewed by the Brazilian Congress.
