Will Hainan be China's first free trade port?

&#187; China's Hainan Province aims at officially completing its formal customs closure operations on 18 December 2025, making it the nation's first Free Trade Port (FTP).

Will Hainan become a high-level free trade zone?

HAIKOU, China, Dec. 18, 2025 /PRNewswire/ -- A report from Hainan International Media Center: China's southern island province of Hainan officially launched island-wide special customs operations on Thursday, a key step in developing the Hainan Free Trade Port (FTP) into a globally influential high-level free trade zone by the mid-century.

What is the policy backbone of Hainan's FTP?

The Guiding Opinions of the CPC Central Committee and the State Council on Supporting Hainan's Comprehensive Deepening of Reform and Opening Up issued in April 2018 and Overall Plan for the Construction of Hainan Free Trade Port issued in June 2020 are the policy backbone of Haian's FTP.

Will Hainan free trade port be open in 2025?

Certain goods currently banned or restricted nationwide will enjoy open policies in Hainan. The State Council Information Office (SCIO) holds a press conference on the development of Hainan Free Trade Port in Beijing, capital of China, July 23, 2025. (Xinhua/Pan Xu)

Under the new arrangements, the tropical island, covering more than 30,000 square km and about a 1.5-hour flight from Hong Kong, has been designated a special customs supervision zone.

In Hainan, raw materials can be imported tariff-free, and income tax rates are lower. If the processed goods are later sold to the Chinese mainland, they can still enjoy zero tariffs.
