How do I ship solar panels overseas?

Ocean freight is typically the most cost-effective way to ship solar products overseas, while air freight is usually a faster option for projects with strict deadlines. Once a solar panel shipment arrives at the destination country, it can be moved inland through a variety of intermodal transport methods.

How long is the validity of export / import licence / permit?

The validity of export / import licence / permit issued by the Directorate of Trade is normally six months from the date of issue, and can be extended for three months period at a time.

What are the export restrictions in Myanma?

(b) Rubber - After 45% of produce has been sold to Myanma Perennial crops Enterprises, the rest 55% shall be exported. 8 percent commercial tax and 2 percent income tax shall be payable in foreign currency for all export from private sector. How long does it take to register an export?

An export must register as a company authorized to engage in international trade and then register as an exporter with the Directorate of Investment and Company Administration (DICA), Ministry of Investment and Foreign Economic Relations. Registrations can be up to five years. DICA has a One Stop Service (OSS) to facilitate registration.
